Intellectual Property

- Submitted an expert report in a patent infringement matter involving the configuration and use of various AUTOSAR-compliant electronic control units installed in a variety of automobiles. The dispute involved the alleged infringement of patents covering distributed control and monitoring systems and the sharing of information in a distributed framework within an automobile. Analyses included a review of the patent holder's past licenses, third-party licenses, design-around alternatives, analysis of accused vehicle sales, and the calculation of reasonable royalties, and provided responses to plaintiff's expert's analysis of reasonable royalty damages.
- Submitted an expert report in a copyright infringement matter pertaining to the alleged misappropriation and use of various artistic works and installations by a well-established furniture retailer in connection with the promotion and sale of furniture. Analyses included review of the retailer's profit and loss statements, purchase order history, invoices, and promotional materials and the calculation of revenues, costs, and profit subject to disgorgement.
- Assisted in a series of patent infringement matters involving multiple manufacturers of fitness tracking devices. The dispute involved the alleged infringement of patents covering the transfer of data between a data capture device (e.g., a smartwatch) and a web-based data hosting server, via a Bluetooth-enabled mobile device. Analyses included a review of the companies' licenses, third-party licenses, design-around alternatives, a detailed analysis of accused sales, costs and profits, and the calculation of reasonable royalties.
- Assisted in a patent infringement matter involving a large smartphone manufacturer alleged to have infringed patents covering certain technologies relating to mobile device security. Analyses included a review of the companies' licenses, design-around alternatives, consumer surveys, a detailed analysis of the manufacturer's sales, costs and profits, and the calculation of reasonable royalties.

The dispute involved the alleged infringement of patents covering various aspects of the transmittal of data packets in a cloud-based network and certain related efficiency gains associated with virtual machine density. Analyses included a review of the companies' licenses, third-party licenses, design-around alternatives, a detailed analysis of the manufacturer's sales, costs and profits, analysis of the increase in paid virtual machine hours attributable to the patented invention, and the calculation of reasonable royalties.

The dispute involved the alleged infringement of patents covering VoIP quality of service and voicemail technologies. Analyses included a review of the patent holder's past licenses involving the patents, third-party licenses, designaround alternatives, consumer surveys, a detailed analysis of the alleged infringer's extent of use of the accused VoIP systems, and the calculation of reasonable royalties.

- Submitted an expert report in a theft of trade secrets matter involving mobile vehicle service providers. The dispute involved the alleged theft of certain confidential information and trade secrets contained in an investor pitch deck. Analyses included a review of the alleged trade secrets, review of the companies' sales and profits, and responses to plaintiff's expert's analysis of the alleged lost profits sustained by plaintiff.
- Assisted in a theft of trade secrets matter involving the origination and marketing of certain death benefit riders in variable annuity contracts. Analyses included a review of the alleged trade secrets, review of the companies' incremental sales and profits attributable to the death benefit products allegedly claimed by the trade secrets, and the calculation of lost profits and unjust enrichment.

Analyses included a review of the alleged trade secrets, review of the companies' statement of work contracts, a detailed analysis of the plaintiff's expected revenues and profits realized from the sale of valves allegedly claimed by the trade secrets, and the calculation of lost profits, the value of the trade secrets, and unjust enrichment (avoided development costs).
- Submitted an expert report in a trade dress infringement matter involving two ice cream companies. Analyses included a review of the trade dress, the market for ice cream products, and an analysis of the revenues, costs, and profits realized by the alleged infringer from the improper use of the dress. Provided deposition testimony on opinions.
- Assisted in a trademark infringement matter involving the use of a federally-registered mark in connection with the branding and promotion of a nationally broadcast reality television show. Analysis included a review of the trademark, an analysis of the revenues, costs, and profits realized by both the network and production companies from the improper use of the mark (unjust enrichment), and the calculation of reasonable royalties and corrective advertising costs.

Breach of Contract

- Assisted in a contract dispute in a chapter 11 bankruptcy proceeding involving over 35 debtors in the gaming industry. Analyses included an evaluation of the casino industry throughout the U.S. and the casino operations of the debtors with properties in Atlantic City, Indiana, and Nevada.
- Assisted in a shareholder dispute related to several tribal gaming casinos located in Washington and Oregon. Analyses included an assessment of the Washington and Oregon gaming industry and the valuation of multiple casino properties and the interests of certain shareholders.

Investigations of Fraud

Analysis included a detailed review of financial statements, expert reports of litigation underlying the patent monetization agreement, and investigation of internal correspondence amongst alleged wrongdoers.

Valuation
